European Parliament and Council Regulation (EC) No 1907/2006 (Corrigendum 29 May 2007), on Registration, Evaluation, Authorization and restriction of Chemicals (REACH), entered into force in June 2007.

The purpose of this Regulation is to ensure a high level of protection of human health and the environment, including the promotion of alternative methods for assessment of hazards of substances, as well as the free circulation of substances on the internal market while enhancing competitiveness and innovation.

This declaration considers the most recent update to the REACH List of January 19th 2021.

All products listed below meet the requirements and restrictions of the REACH regulations in force.

RoHS-1 Directive EU/2002/95/EC which took effect on July 1, 2006 restricted the use of 6 substances in all electrical and electronic equipment (EEE) placed on the market in the European Economic Area. On January 3rd 2013, RoHS-1 (2002/95/EC) was replaced by the 2011/65/EU (aka "RoHS-2") directive, which did not add to the existing list of 6 substances. On June 4th, 2015 the EU Council approved an amendment to the RoHS Directive EU/2015/863 (aka "RoHS-3") by adding four phthalates to be restricted in electrical and Electronic Equipment (EEE) sold in the European Union from July 22, 2019.

All products listed below meet the requirements and restrictions of the RoHS regulations in force.

Mercury (Hg)	< 0% or 1000 ppm
Cadmium (Cd)	< 0.01% or 100 ppm
Hexavalent chromium (Cr+6)	< 0% or 1000 ppm
Polybrominated diphenyls (PBB)	< 0% or 1000 ppm
Polybrominated diphenyl-ethers (PBDE)	< 0% or 1000 ppm
Bis(2-Ethylhexyl) phthalate (DEHP)	< 0% or 1000 ppm
Benzyl butyl phthalate (BBP)	< 0% or 1000 ppm
Dibutyl phthalate (DBP)	< 0% or 1000 ppm
Dioctyl phthalate	< 0% or 1000 ppm
